



It is the responsibility of the freight carrier to unload all materials from the delivery vehicle, including pallets/crates.
Pallets and Crates
<ul style="list-style-type: none"> a. A BOL is required for all drivers to have in their possession at delivery and must match the BOL that we have on file. DE must have a copy of all inbound and outbound BOLs, freight, or weight bills. b. From September to May, we have heavy traffic in front of our warehouse. We advise delivery before 1pm. c. All delivery trucks must have a lift gate for pallets/crates. d. Special and prior arrangements need to be made for any item with weight requiring a forklift or crates that exceed 6' x 6' dimension.

FREIGHT TERMS & CONDITIONS

Drayage is the term for handling freight. If you are sending freight for the event, it is important to work through DE Expo and Event Services. Do not send your freight directly to the event facility. Area facilities typically do not receive and hold freight. DE's fees for drayage include handling of your freight only. All charges incurred for shipping are separate, and must be arranged through a carrier.

- a. Please fill out the Freight Forms completely, and email/fax them to us so we know how much freight to expect and when to expect it. NO FREIGHT WILL BE ACCEPTED ON A COLLET BASIS and payment for freight services must be made before your freight arrives at our warehouse.
- b. Exhibitors are responsible for adequately packaging goods and properly filling out paperwork.
- c. Label each piece as follows: Event Name, Company Name, Booth Number. This will ensure proper placement of freight. Note on the label or package the total number of pieces, such as "1 of 6," "2 of 6," etc.
- d. Exhibitors will be responsible for all shipping charges. Storage fees will apply if containers are received at our warehouse prior to (3) weeks before the event (\$0.01/lb. per day). If freight arrives at our warehouse during or after the set-up of the show, an additional charge of up to \$150 may apply if a special trip to the warehouse is necessary.
- e. Design Events, Inc. (DE) will not be liable for any damage to uncrated or improperly packaged materials or concealed damage.
- f. DE must be notified if the number/type of items in your booth is not correct. You must contact the DE Customer Service Representative at the event. No refunds will be made for items missing from your booth if DE has not been notified during the Customer Service hours listed on Page #2.
- g. DE will not be responsible for loss, theft, or disappearance of exhibitor's materials after these items have been delivered to the exhibitor's booth, or before they are picked up from the booth for reloading after the event.
- h. DE may, at our option, open and inspect your packages before or after you give them to us to handle for shipment.
- i. DE's liability will be limited to the physical loss of, or damage to, the specific article which is lost or damaged. In any event, DE's maximum liability shall be limited to \$0.30 per pound per article with a maximum liability of \$50.00 per item, or \$700.00 per shipment, whichever is less.
- j. DE will not be liable to any extent for any actual, potential, or assumed loss of profits or revenues, or for any collateral costs, which may result from any loss or damage to an exhibitor's materials which may make it impossible or impractical to exhibit the same.
- k. DE will not issue refunds for exhibitors who send freight or equipment orders, but subsequently fail to attend the show.
- l. DE will issue a 10% billing fee if your charges are not paid by the end of the show.
- m. International shipments must include the required documents for return shipping. Your customs broker can supply these documents. Lack of documents will delay return shipping.
- n. Exhibits and materials for which arrangements have not been made with DE, will not be transported to our warehouse for return shipping.
- o. DE reserves the right to route exhibit materials via an alternate carrier in the event of a failed pickup.

ELECTRICAL TERMS & CONDITIONS

- a. Equipment furnished pursuant to this service shall be and will remain the property of Design Events, Inc. (DE), and shall be installed and removed ONLY by DE personnel or designates.
- b. Exhibitors are not allowed to share power. Exhibitors shall not be permitted to add wattage except upon ordering the same from DE.
- c. All electrical outlets will be installed at the center rear of the booth, unless otherwise designated.
- d. All wiring, motors, electrical installation, multiple outlet plugs, and connections must be approved by DE prior to use, to prevent the overloading of circuits.
- e. DE is not responsible for voltage fluctuations of power failure because of temporary conditions. DE recommends the use of a surge protector on all sensitive equipment.
- f. Exhibitors agree to pay for any damage to or loss of the DE equipment rented to them under this agreement. Exhibitor also agrees to pay for any DE equipment not available for pickup and return to DE at the conclusion of the event.
