### **Off-Premise Beer Retailer State License Required by March 31, 2019**

*In 2017, the State Legislature passed HB442*, a new law that requires off-premise beer retailers to obtain a license in order to purchase, store, sell, or offer for sale beer for consumption off the retailer's premises.

The law says: **Beginning on July 1, 2018, a person who operates as an off-premise beer retailer shall obtain an off-premise beer retailer state license on or before March 1, 2019.** The commission shall establish a deadline for each off-premise beer retailer to submit to the department an application for an off-premise beer retailer state license. Off-premise beer retailers may continue to operate without an off-premise beer retailer state license through February 28, 2019.

**The Application is still being developed**, which must be submitted along with a nonrefundable application fee of \$75, or an initial license fee of \$250 that is refundable if the commission does not issue the off-premise beer retailer state license. The law also requires written consent of the local authority; a copy of the person's current business license; a floor plan of the premises that outlines the location of each beer display (two allowed); and a signed consent form stating the person will permit any authorized representative of the commission or the department or any law enforcement officer to have unrestricted right to enter the licensed premises. More information will be shared as it becomes known.
