



That's the question being asked, and put to the test (or more accurately, a "tabletop exercise") involving emergency response agencies from the state and



federal levels in Washington, Oregon and Idaho? Let's hope they talk to the private sector-- those of us in the industry who actually operate this complex system. That is exactly what happened in Boise on September 19 and 21, 2023. IPM&CSA and EMA rep-



resentatives are engaged in this and future exercises for emergency response to disasters of all kinds. While Idaho doesn't often have some of the severe weather other parts of the country endure (think hurricanes & tornadoes), we do have the possibility of real disruptions to the

fuel supply and severe damage to infrastructure (think pipeline breaks, earthquakes, and wildfires). IPM&CSA and EMA are happy to work with emergency agencies at all levels, and our private partners to become better informed, more knowledgeable, and hopefully better prepared when disaster strikes.

LEGISLATION, RULES & REGULATIONS

IPM&CSA is on top of it when Idaho is asked to weigh in with our elected officials and with state and federal agencies. Here are a few of the things that we are working on:

- Credit Card Fees Idaho's U.S. Senators are key votes on new bills in Congress to fight unfair credit card fees. Your advocacy as an Idaho business is critical to success.
- Tobacco and Vaping We work closely with our national partners to weigh in on federal rules related to these products whenever (yet another) burdensome regulation arises.

• **DEQ/PSTF/NEVI** – IPM&CSA is always engaged with state agencies as they develop new programs and spend money on issues that matter to our industry. From environmental regulations and underground storage tanks to electrical vehicles, we are vigilant and ready to jump into the fray whenever needed.
