### GOVERNMENT AFFAIRS - YES, WE DO LOTS OF THAT TOO

*Your pocketbook* is mostly safe until our legislature meets again in February, 2025. However, local governments and state agencies are busy crafting new ordinances and regulations which may impact your business. Your association is engaged with the City of Reno as they look to make changes to the alcohol, tobacco and gaming ordinances in the city. Early in November, Fueling Nevada hosted a meeting with Clark County air quality officials to discuss Ozone rules and changes to their State Implementation Plan or SIP.

Election 2024 is only 12 months away, and while the presidential race will suck all the oxygen out of the room, the Nevada legislature is where the action is for you. Nineteen of the 27 Democrats in the Assembly have said they will seek re-election - that means 8 Democrats will not seek re-election. In the State Senate, Democrats held a 13 to 8 majority in 2023, just shy by one seat of a 2/3 supermajority. If Republicans are unable to maintain or grow their seats, Democrats will be able to override any and all of the Governor's vetoes, including the record 74 he vetoed from last session.

As a result of the 2020 Census, the majority party – Democrats - redrew legislative districts, making it very difficult for Republicans to be elected.

All is not gloom and doom - we live in a beautiful state with good business opportunities for the most part! We are blessed, a sentiment we should remember during the holiday season!
