## 2025 Legislative Session Wrap up

#### **What Happened?**

#### Taxes - Property / Income / Sales Tax

H40 Income Tax rate reduction - \$253 million in tax relief, reduces income tax rate from 5.695% to 5.3%, Passed House 63-7, Passed Senate 27-8, LAW effective 1.1.25

H231 Grocery tax credit - increases grocery tax credit \$120/\$140 (over 65) to \$155 per person, providing \$50 million in tax relief. Passed House 61-6, Passed Senate 30-3, LAW effective 1.1.25

H304 – Property Tax Relief & School Facilities Funding - \$1M property tax relief (50/50 school facilities fund/homeowner property tax relief acct) Passed House 68-0, Passed Senate 35-0, LAW effective 3.26.25

#### **Tobacco / Vaping / Alcohol**

H133 Moves tobacco Rules to Statute, Passed House 62-7, Passed Senate 35-0, Signed by Gov

#### **Employment**

Unemployment Insurance & Workers Compensation (several bills)

#### **Transportation / Vehicles / EVs**

H25 Sales tax, transportation / TECM – Diverts additional General Fund/Sales tax funds to local government and transportation, \$122M to \$185M from FY26 – FY28 and beyond, Passed House 70-0, Passed Senate 34-0, LAW effective 4.1.25

H86 Electric vehicles charge stations, local pre-emption, Passed House 61-9, Passed Senate 28-7, LAW effective 3.11.25

#### **Energy & Environment**

IDAPA 58.01.24, Rules for Petroleum Release Correction Action – OTS C3034

#### Retail - Swipe Fees / SNAP

H109a SNAP Candy and soda exclusion Passed House 38-32, Passed Senate 25-10 LAW effective 7.1.25

#### What Didn't:

#### **Tobacco/vaping/alcohol**

H244 Vape Directory (sponsored by Altria/RJR) (IPM&CSA Supported / Did not receive a hearing in House Health & Welfare)

H314 Vape Tax (sponsored by Altria/RJR) (IPM&CSA Supported / Did not receive a hearing in House Revenue & Taxation)

#### **Transportation / Vehicles / EVs**

H78 Electronic drivers' licenses – Authority to ITD to issue electronic ID cards & driver's licenses. Passed House 37-33, Held in Senate Transportation cmte.

#### **Taxes**

H375 – Local Option Taxation, Provides for sales taxing authority to local units of government, requires description of services or products subject to the tax, provides for 4 year term, and maximum levy rate of 2%. For consideration in 2026 session. Sponsor plans community engagement in interim.

HJR005 – Local Option Taxation, proposes a constitutional amendment that creates the option for counties and municipalities to levy a local sales and use tax. Sponsor plans community engagement in interim.

#### Retail – Swipe Fees / SNAP

S1055 Electronic payments, taxes & tips exempt

H70 Plastic bags, regulation / State pre-emption eliminated

H68 Minimum Wage / State pre-emption eliminated
