### TSA Warns CDL Drivers to Apply Early for HME Renewals or Risk Temporary Loss of Operating Authority

Drivers seeking to renew or obtain a hazardous material endorsement (HME) must undergo a Transportation Security Administration (TSA) security threat assessment. The security threat assessment includes driver security and criminal background checks and fingerprinting. Typically, the threat assessment process takes 45 days. However, TSA is recommending that all applicants for hazardous material endorsement (HME) renewals or first-time enrollments submit their applications and fingerprints at least 60 days prior to their expiration date. The TSA is experiencing increased demand for HME renewals and new enrollments and the processing times for applicants are exceeding the normal 45-day turnaround period. Drivers applying for renewal outside the 60-day processing period risk temporary loss of their authority to haul hazardous materials.

#### TSA HME Application Process

Drivers may complete the <u>HME application online</u> or apply in person at the nearest TSA application center. Drivers can <u>schedule an appointment online</u> or by calling <u>(855) 347-8371</u> weekdays, 8 a.m. to 10 p.m. ET. Walk-ins are welcome at TSA application centers, but appointments take priority.

When applying at a TSA application center, drivers must be prepared to:

- Provide required documentation and fingerprints.
- Bring a current U.S. passport or a driver's license and birth certificate. See other acceptable documents.
- Pay a non-refundable fee valid for five years with a credit card, money order, company check or certified/cashier's check. (New applicant: \$86.50; New applicant reduced rate: \$41.00. All reduced rate applicants must already possess a valid TWIC card and be licensed in a state that accepts the TWIC threat assessment in place of the HME threat assessment.

Drivers may **check the status** of their HME application online at any time.

*Important!* Drivers in Wisconsin, Virginia, Pennsylvania, Florida, Maryland, Kentucky, New York and Texas must go to their local Department of Motor Vehicles for HME application and fingerprinting. These drivers cannot use TSA application centers.

#### Reminder: 2024 Federal Motor Fuel Income Tax Rates and Credits -- WHAT'S NEW?

Superfund Tax: The Superfund tax was reinstated beginning January 1, 2023 and is adjusted annually for inflation. The inflation adjusted rate for 2024 is \$0.26 cents per barrel of crude beginning January 1, 2024. The tax is paid by refiners and crude oil importers. No party below the terminal rack is liable for the tax. Refiners and importers pass the tax down as a cost folded into the wholesale rack price of petroleum products and not as a tax. Marketers are not required to break this "tax" out on invoices or contract bids.

Rates in the below link include the 1/10<sup>th</sup> cpg non-refundable LUST tax imposed on both dyed and clear liquid fuel. There is no refund of the LUST tax. Tax exempt parties are required to pay the .001 cpg.

#### **Inside the Beltway Update**

Last week, the House and Senate passed the National Defense Authorization Act (NDAA) – the final legislation for 2023. While the House left DC, Senate Majority Leader Schumer (D-NY) kept Senators in DC in an attempt to pass additional funding for Ukraine as well as funding for Israel, Taiwan, and border security. Late Monday, Senate Republican Whip John Thune (R-SD) said the foreign aid package would be pushed to 2024. Nonetheless, with Senators in DC, Leader Schumer aimed to advance nominations including the long-stalled confirmation of Joe Goffman to run the EPA's air office. Like all EPA pending confirmations, Senator Joe Manchin (D-WV) opposes Goffman's confirmation over the Administration's power plant rule.

The U.S. Department of Energy is working to advance Inflation Reduction Act (IRA) programs before year end. On Monday, DOE announced the availability of \$530 million for technical assistance competitive grants meant to spur the adoption and implementation of the latest model energy codes, zero energy codes, building performance standards and other codes that achieve equivalent energy savings. Meanwhile, Senator Manchin asked the Government Accountability Office to rule on whether the IRA's EV tax credit guidance is considered a "final rule" which would allow Congress to overturn the guidance through the Congressional Review Act process. The White House fired back defending the administration's rollout of the EV tax credit. "We're implementing the bill as written and I think that we're doing so in a way that has fealty to the language that was written into the bill," White House clean energy chief John Podesta told reporters.

On clean energy policies, 100 House Democrats sent a letter to banking regulators urging them to revise rules that Democrats argue could threaten clean energy transition. The lawmakers argue that the proposed rule would make it prohibitively expensive for banks to extend tax equity financing for clean energy project development. They point to concerns that the change could mean annual tax equity investments in the clean energy sector shrink by up to 90 percent — or potentially push banks to exit the renewable tax equity market entirely.

The EPA sent a proposed rule to allow the year-round sale of E15 in certain Midwest states to the Office of Management and Budget (OMB) this week. The proposed rule stems from a petition by a group of Midwest governors to permit the summertime sale of E15 in their states, which was authorized under a provision in the Clean Air Act to permit an exclusion from the 1 pounds per square inch (PSI) waiver for E10 upon notification by a governor that the higher reid vapor pressure (RVP) limit will increase air emissions in that state. However, the Administration can delay a decision on permitting the sale of E15 for up to two years (through 2025) because the waiver would require the creation of a boutique fuel exclusive to the petitioning states, thus limiting gasoline supply to the region. A study conducted by Baker & O'Brien found that eliminating the RVP waiver for summertime E10 and introducing a new gasoline blend to just the petitioning states would likely cost \$500-\$800 million. EPA determined the request would result in a shortage of gasoline in the petitioning states for summer 2023, therefore, deciding to delay implementation until summer 2024 for Illinois, Iowa, Minnesota, Missouri, Nebraska, Ohio, South Dakota and Wisconsin. The EPA is expected to punt the issue into 2025.

After the Senate departs this week, DC will be quiet until Congress returns on January 8, 2024, and quickly moves to consider appropriations bills that are set to expire January 19 and February 2, 2024.

#### **Another Set Back for Oil Majors in Climate Lawsuit**

In another blow to major oil company defendants in climate change cases, a federal court of appeals in D.C. rejected an attempt by ExxonMobil, BP, Chevron, and Shell to move the case to a federal court. The case was brought against the major oil companies by the District of Columbia Attorney General under a local consumer protection law. The AG alleges that the law was violated when the majors failed to disclose to consumers the impacts their businesses have on global climate change. The court of appeals found that no basis exists for federal jurisdiction, and it sent the case back to the D.C. court. Thus far, federal courts have been inclined to view global warming as an international problem that cannot be solved by state and local actions. Federal courts would be a better forum for oil company defendants to argue that a coordinated federal response to global warming is required, and that federal law should supplant state and local laws in this area.
